#### Memorandum

The Association of Professional Academic Institutions, West Bengal represented before the Fee Structure Committee constituted by Govt. of West Bengal in the Deptt. of Higher Education for revision of the existing fee structure for B.E/B.Tech courses so as to enable the colleges to extend the benefit of the increase in the pay structure of the teachers based on UGC/AICTE scale of pay and that of the non-teaching employees based on ROPA 2009 of the State Govt.

The Fee Structure Committee vide their resolution of the 50<sup>th</sup> meeting dated 12.06.2009 and 54<sup>th</sup> meeting dated 28.05,2010 respectively have sent their recommendations to the State Govt. on the revised fee structure for the Engineering & Technology courses including Pharmacy and a separate fee structure for the students admitted under Management Quota in such courses, for implementation by the State Government. The State Govt. had approached the Fee Structure Committee on 26.5.2010 to recommend a suitable fee structure for the students admitted under Management Quota seats in private self-financing colleges.

Keeping in view of the above two recommendations of the Fee Structure Committee, the Governor is pleased to revise the existing fee of Rs.41,000/- per annum with one time admission fee of Rs.3000/-, reasonable library fee and refundable caution deposit and other university fees as applicable for the under graduate engineering & technology courses in the private self-financing colleges of the State including Pharmacy and implement the same along with a separate fee structure for the students admitted under Management Quota from the academic session 2010-11 in the following manner:

- i) Maximum Tuition Fee for the new entrants in Engineering courses in Private Self-Financing Engineering Colleges from the academic session 2010-11 will be Rs.55,000/- per annum. No separate development fee will be realised from the students.
- ii) This enhancement of maximum tuition fee is subject to the condition that colleges charging enhanced tuition fee will extend the benefit of increase in revised pay structure announced by UGC/AICTE for teachers in Engineering

and Technological Institutions, if they are not already paying similar or higher pay.

- iii) Besides the aforementioned tuition fee, colleges may charge one-time admission fee of Rs.4000/- for the entire course at the time of admission, appropriate library fee, refundable caution money, any fee charged by the University for benefit and welfare of the students, and other usual fees charged by the University like registration fee, examination fee etc.
- iv) No capitation fee in any kind or form will be charged by any of the colleges.
- v) Full and Half-Free studentship and other fee waiver benefits as existing will continue until further review.

#### **Management Quota seats**

- i) Maximum tuition fee for entrants in M.Q./N.R.I. seats in the Engineering colleges is to be fixed at 3 times of the tuition fees for non-management quota students in operation, from academic session 2010-2011.
- ii) No college will charge or realize any tuition fees beyond the prescribed maximum limit and any extra tuition fees realized from students admitted in NRI/MQ seats may be treated as capitation and profiteering.
- iii) All other permissible fees such as Admission fee, Library fee, refundable caution money, University fees will be the same as prescribed for non-management quota students.
- iv) Existing guidelines of the State Govt. on full and half free studentship @ 10% and 5% respectively for opting Management Quota would continue as usual.

The revised fee structure will come into force from the academic session 2010-11 in respect of the students admitted in academic session 2010-11 onwards.
