You are aware that last date of registration for Pre-matric and Post-matric scholarships and scholarship for top class education for Students with Disabilities has been extended to 31.10.16.

Till date on line registration is very poor in the State. Till 25.10.16 no. of students registered is Pre-matric-341, Post-matric –877 and Top-class - 6, vis-a-vis Quota/slot – Pre-matric -3461, Post-matric –1253 and Top-class -11. In view of this, I would request you to see that the concerned officials of your Department take necessary action and arrange wide publicity of the scheme among the Students with Disabilities through the Educational Institutions so that eligible students with disability are not deprived of the benefits of the scheme.
