**Sub:** Proposal for Grant of Interim Relief (IR) to the serving College and University teachers and pensioners covered under UGC/AICTE Pay Scale.

Sir,

I am directed to refer to the subject mentioned above and to say that this department moved to Finance Department with the proposal for extending the benefit of grant of Interim Relief (IR) to the serving and retired teachers of Government Colleges, Government-aided Colleges and State aided Universities in the State, in the same manner as that have been allowed for the whole time regular serving State Govt. employees and such employees of Govt. Sponsored or aided educational institutions, local bodies, statutory bodies, boards, corporations, undertakings etc. and their pensioners in terms of Finance Departments' memo no. 2926-F(P) dated 02.06.2016 and no. 224-F(Pen) dated 03.06.2016 read with 3059-F(P) dated 08.06.2016

The Finance Department has opined that since the college and university teachers as well as pensioners covered under UGC/AICTE Pay Scale are not included in the Terms of Reference of the 6<sup>th</sup> Pay Commission as specified in Finance Department's order no. 8071-F(P) dt. 27.11.2015, they are not entitled to Interim Relief (IR) for the present.

This Department, therefore, regrets its inability to consider the matter.
