Sir,

With reference to your Memo No. 1409(T) dated: 28.11.2016, I am directed to state that Dr. Subrata Mondal served Jalpaiguri Government Engineering College, Jalpaiguri as a Professor of Training & Placement for the period from 02.6.2003(F.N.) to 31.05.2006(A.N.) when he was released from this Department to join his new assignment as the Principal of Government Polytechnic under West Bengal General Service at Birla Institute of Technology, Kolkata under Technical Education & Training Department, Govt. of West Bengal.

An arrear amount of Rs.1,26,427/- for the period from 01.01.2006 to 31.05.2006 in favour of Dr. Subrata Mondal, Ex-Professor, Training & Placement, Jalpaiguri Government Engineering College, was created for Revision of Pay & Allowances under AICTE scale Vide this Department's G.O.No. 434-Edn (T)/ (T)-10M-36/09 dated: 26.07.2010 & Memo. No. 518-Edn (T)/ (T)-10M-36/09 dated: 13.09.2010.

The college authority submitted a Gross claim for arrear salary incurred for the period from 01.01.2006 to 31.03.2009 to the Directorate of Technical Education, W.B., in the financial year: 2012-2013. At that time, the name of Dr. Mondal was omitted inadvertently from the list of Gross Claim. Subsequently, the college authority submitted the arrear claim of Dr. Mondal duly verified by the Accounts Officer via Directorate of Technical Education, West Bengal to this Department.

In this context, the Department of Higher Education accords sanction of an amount of Rs. 1,26,427/- (One lakh twenty six thousand four hundred twenty seven) as an arrear bill for the period from 01.01.2006 to 31.05.2006 in favour of Dr. Subrata Mondal, Ex-Professor, Training & Placement, Jalpaiguri Government Engineering College in terms of Treasury Rules 4.024. The fact of drawal of arrear shall be recorded in the service book of Dr. Mondal.
