## MEMORANDUM

In terms of P & AR Department's Order No. 283-PAR-23012/11/2020-eGov, dated 09.02.2021 read with this Department Order No 797-HE/Estt/4A-01/21 dated 11.08.2021, 306 nos. of Contractually Engaged IT Personnel (hereinafter referred as CITP) of this Department have been brought under the ambit of P & AR Department's Notification No.192-IT, dated 16.10.2020. Out of the said 306 nos. of CITP, 275 nos. of existing CITP were originally engaged otherwise than in terms of Memo No.5859-F(Y), dated 22.07.2013, Memo No.1084-F(Y), dated 15.02.2014 and Memo No.249-F(Y), dated 15.01.2016.

- In terms of para 2. a) of Finance Department's Memo No.1086- $F(P_2)$ , dated 01.03.2024, these 275 nos. of CITP, who are not covered by Memo No. 4878- $F(P_2)$ , dated 05.12.2022 or memo No.1875- $F(P_2)$ , dated 17.04.2023, have been classified into 6 broad categories on the basis of nature of job assigned to him/her on the date of initial engagement (primary criterion) and the minimum qualification and experience on the date of his/her initial engagement (secondary criterion).
- Now, in terms of para2. e) of Finance Department's Memo No.1086-F(P2), dated 01.03.2024, each of the 275 nos. of CITP as detailed in annexure-I of this order is hereby allowed to draw the Provisional Professional Fee/Consolidated Remuncration as mentioned in the respective cell of column 4 against his/her name in column 2 on the basis of Provisional Category assigned to him/her in the respective cell of Column 3 of annexure-I. In determining such Professional Fee/Consolidated Remuneration, necessary provisions of Finance Department's Memo No.1086-F(P2), dated 01.03.2024 has been strictly observed.
- This order is a provisional order and the final order will be issued notifying ratification of P & AR Department after making required modification, if any, as advised by P&AR Department. This order will originally come into effect only after getting ratification from P&AR Department.
