Dr. Sanat Kumar Ghosh & Ors.) through solemn order dated 08.07.2024 (hereinafter referred to as the said order);

WBG/AB/1678 dated 28.01.2026** with effect from the date of joining for a period of four years or till he attains the age of seventy years, whichever is earlier.
