Dr. Sanat Kumar Ghosh & Ors.) through solemn order dated 08.07.2024 (hereinafter referred to as the said order);

AND WHEREAS, in terms of the said order, names of persons to be appointed as Vice Chancellor as per the recommendation of the Search-cum-Selection Committee for the **Jadavpur University** as constituted in terms of the said order, were placed before the Hon'ble Chancellor through the Hon'ble Chief Minister indicating the choice of the Hon'ble Chief Minister in order of preference;

AND WHEREAS, in terms of all subsequent orders including order dated 06.10.2025 of the Hon'ble Supreme Court in the matter of SLP 17403 of 2023 (State of West Bengal Vs. Dr. Sanat Kumar Ghosh & Ors.), the Hon'ble Chancellor has approved the name of **Prof. Dr. Chiranjib Bhattacharjee** as the Vice-Chancellor of the **Jadavpur University**;

NOW, THEREFORE, in terms of the above mentioned orders of the Hon'ble Supreme Court and in exercise of the powers conferred by the **Jadavpur University Act, 1981**, as amended from time to time, the Hon'ble Chancellor is hereby pleased to appoint **Prof. Dr. Chiranjib Bhattacharjee** as the Vice-Chancellor of the **Jadavpur University** with effect from the date of joining for a period of four years or till he attains the age of seventy years, whichever is earlier.
