NOW, THEREFORE, in terms of the above mentioned orders of the Hon'ble Supreme Court and in exercise of the powers conferred by the **Calcutta University Act, 1979**, as amended from time to time, the Hon'ble Chancellor is hereby pleased to appoint **Prof. Dr. Ashutosh Ghosh** as the Vice-Chancellor of the **University of Calcutta** with effect from the date of joining for a period of four years or till he attains the age of seventy years, whichever is earlier.
