NOTIFICATION

NOW, THEREFORE, in terms of the above mentioned orders of the Hon'ble Supreme Court and in exercise of the powers conferred by the **Sadhu Ramchand Murmu University of Jhargram Act, 2017**, as amended from time to time, the Hon'ble Chancellor is hereby pleased to appoint **Prof. Dr. Chandradipa Ghosh** as the Vice-Chancellor of the **Sadhu Ramchand Murmu University, Jhargram** with effect from the date of joining for a period of four years or till she attains the age of seventy years, whichever is earlier.
