O R D E R

The State Government, in order to extend the benefits of the Swami Vivekananda Merit-cum-Means Scholarship Scheme (hereafter referred to as the 'Scheme') to the larger section of meritorious students from poor economic background, pursuing higher studies, has been considering the enhancement of the rate of scholarship in respect of the students of B.V.Sc and AH (four and half years' duration) and M.V.Sc (two years' duration) courses, studying under the West Bengal University of Animal and Fishery Sciences, whose family income is not more than Rs. 2,50,000/- per annum.

With a reference to the letter No: WBUAFS/Edn/SVMCM/1084 dated: 05-06-2024 of the West Bengal University of Animal and Fishery Sciences, read with this Department Order No: 11 – EH/N/M & MS – 06/2013 (Pt. –I) dated: 01-08-2017, the undersigned is directed to state that the Governor is pleased to enhance the rate of scholarship, in favour of the students who are pursuing Bachelor of Veterinary Sciences (B.V. Sc.), from @Rs.1500/- to @Rs.5000/- per month which is at par with the Medical Students (Medical Degree Courses like MBBS, BHMS etc.) as professional courses for the period of four and half years and for M.V. Sciences for two years if they do not receive any other stipend/remuneration (like MD students).

The charges shall be debit able under the HoA "HE/70/2202-80-107-019-34-00-Scholarships and Stipends-V" (State Development Scheme).

Joint Director of Public Instruction (Scholarship & Stipend) at Education Directorate, West Bengal, will act as the Drawing and Disbursing Officer in this matter.


